## **CIRCULAR**

It has been observed that Superintending Engineers/Executive Engineers forward SRO-43 cases without proper securitization resulting in un-necessary delay in processing SRO-43 cases, the dealing Assistants prepare the compassionate appointment cases without going through the check list issued by General Administrative Department vide circular No: 10 GAD of 2015 Dated: 25-02-2015 (Check list copy enclosed).

It is hereby impressed upon all Superintending Engineers/Executive Engineers that the compassionate cases be strictly prepared in light of SRO-43 of 1994 amended from time to time and the families of deceased be timely intimated about the documents/certificates required for processing the compassionate appointment cases

Any deviation/non-compliance in this regard shall be viewed seriously and action against the defaulters shall be initiated.
